3. Apex Inflatables LLC MAKES NO WARRANTIES OF MERCHANT ABILITY OR FITNESS FOR PARTICULAR PURPOSE, OR ANY WARRANTIES, EXPRESSED OR IMPLIED.
4. THIS RENTAL CONTRACT FORMS THE SOLE AGREEMENT BETWEEN THE CUSTOMER AND Apex Inflatables LLC. THE CUSTOMER AGREES TO INDEMNIFY AND HOLD Apex Inflatables LLC HARMLESS FOR ANY CLAIMS FROM CUSTOMERS USE OR MISUSE, INCLUDING ANY THIRD PARTIES FOR LOSS, INJURY, AND DAMAGE TO PERSONS OR PROPERTY ARISING OUT OF THE CUSTOMER'S NEGLIGENCE OR OPERATION INCLUDING LEGAL COSTS INCURRED IN DEFENSE OF SUCH CLAIMS.

RULES

5. NO SHOES, EYEGLASSES, JEWELRY, WATCHES, BELTS
6. NO SOMERSAULTS, DIVING, WRESTLING, ROUGH PLAY, OR FLIPS
7. NO FOOD, DRINKS GUM PETS, OR SILLY STRING
8. KEEP PATRONS AWAY FROM THE BLOWER AT ALL TIMES
9. DO NOT USE AND IMMEDIATELY DEFLATE THE INFLATABLE IF WIND CONDITIONS EXCEED 15 MPH AND OR IT RAINS
